

**WAIVER AND RELEASE OF COLLECTION SITE LIABILITY FOR PARTICIPATION IN
VERITAS GENETICS, INC. COVID-19 TESTING**

This is an important waiver and release of liability. Read carefully.

In connection with the COVID-19 test (the “COVID-19 Test”) I am requesting (either on my behalf or on behalf of another, collectively, the “Recipient”) I acknowledge and agree as follows with respect to the collection of biological samples or specimens and the transportation of such samples or specimens (collectively, the “Collection Services”) to the facilities of Veritas Genetics, Inc. (“Veritas”) by or on behalf of the site at which such samples of specimens are collected (the “Collection Site”, which term includes the entity or entities owning and/or operating such site and/or administering the collection and/or transportation of such samples or specimens):

1. I acknowledge and agree that (i) the Collection Site is providing the Collection Services as a convenience to the Recipient and is not endorsing the professional qualifications of the individuals performing the COVID-19 Test for Veritas or performing the Collection Services for the Collection Site; (ii) the Collection Site itself is not engaging in the practice of medicine or the provision of health and wellness services; (iii) that the Collection Site has not expressly or implicitly indicated that participation in the COVID-19 Test is required for any reason; (iv) in undertaking the Collection Services, the Recipient may be engaging in activities that involve a risk of injury that might result not only from his or her own actions, inactions, or negligence but also that of others or the condition of the premises or of any equipment used and that there may be other risks neither known nor reasonably foreseeable at the time; and (v) assumes all the foregoing risks and accepts personal responsibility for any damages following any such injury .
2. I acknowledge, understand and agree that a determination as to whether or not participation in the COVID-19 Test is medically appropriate can be made only by the Recipient and his or her physician and any participation without a medical evaluation is a risk voluntarily and knowingly assumed by the Recipient.
3. I acknowledge and agree that any and all interpretations of the results of the COVID-19 Test are performed solely by Veritas and that it is the responsibility of the Recipient to identify and carry out any follow-up with Recipient’s personal physician or other health care provider.

4. I release, waive, discharge and covenant not to sue the Collection Site, its officers, directors, agents, employees and other affiliates or related parties of the Collection Site, all of which are hereinafter referred to as “releasees,” from any and all liability to the Recipient, and the Recipient’s family, beneficiaries and survivors, for any and all claims, demands, losses, or damages on account of injury, including death, or damage to property caused or alleged to be caused in whole or in part by the negligence of the releasee or arising out of alleged strict liability or otherwise, and including any claims relating to the COVID-19 Test process and procedures, the analysis, and disclosure of the test results.

5. I agree that this Waiver and Release is to be construed according to the laws of the state in which the Collection Site is located and, if any portion thereof is held invalid, it is agreed that the remainder continues to have full legal force and effect.
